## Programme Outline

The purpose of this qualification is to prepare a learner to operate as an Early Childhood Development Practitioner.

An Early Childhood Development Practitioner plans and prepares early childhood activities, facilitates and mediates learning, observes and assesses the progress of children, and reflects on learning in an inclusive, play-based environment to support holistic development of children (from conception - school going) in different centre-based or non-centre based settings.

### A qualified learner will be able to

- Plan and prepare a broad-phase learning environment and stimulating activities that meet the holistic needs of all children in centre-based or non-centre-based settings.
- Facilitate and mediate all aspects of the daily programme in a centre-based or non-centre based setting.
- Observe, assess and record each child's progress according to the age and stage.
- Compile a report of each child's progress.
- Maintain and promote the well-being, health, nutrition, safety and protection of children.

### Rationale

The Occupational Certificate: Early Childhood Development has been designed to meet the needs and interests of the early childhood development sector in a variety of settings and contexts with an inclusive focus on education, health and safety issues, amongst others.

This qualification will provide a means to give recognition to practitioners at an entry level, thus making it possible for practitioners to increase their employment prospects within the Department of Basic Education.

The Department of Social Development, through the registration of early childhood development centres and/or sites, may also provide business opportunities to successful practitioners who may wish to establish early childhood centres and/or sites. It will also provide access to a recognised career path and at the same time provide the field with suitably qualified professional practitioners. The qualification will provide opportunities to people who wish to enter and/or continue learning in the early childhood development field, which include the employed, under-employed but not qualified, and school leavers.

### Admission Requirements

**Recognition of Prior Learning (RPL):** RPL for access to the external integrated summative assessment: Accredited providers and approved workplaces must apply the internal assessment criteria specified in the related curriculum document to establish and confirm prior learning. Accredited providers and workplaces must confirm prior learning by issuing a Statement of Results or certifying a Work Experience Record.

**RPL for access to the Qualification:** Accredited providers and approved workplaces may recognise prior learning against the relevant access requirements.

## **Entry Requirements**

- National Certificate Vocational (NCV) at NQF Level 3 or
- Any other NQF Level 3 qualification.

## **Tuition Fees**

### Cost and payment plan

- The total cost to obtain the full qualification is R11 000.00 per learner per annum.
  - An admin fee of R2000.00 per annum is required at the beginning of each year.
  - The remaining R9 000.00 can be paid off over 18 monthly instalments of R500 per month.
  - No students will be allowed to participate in final assessments if fees are outstanding.
  - Fees do increase should the student exceed the study period.

## Programme Outline

### The purpose of the qualification is to

- Provide access to a recognised educator qualification at Level 6 for ECD educators who have a Level 4 or Level 5 certificate in ECD, providing a bridge between non-formal and formal learning programmes.
- To enable educators / learners to plan and implement a learning programme which is based on their knowledge of child development from birth to nine years and which helps children in a specific phase work towards achieving the learning outcomes of the national school curriculum (where appropriate).
- To improve community-based ECD services for young children by raising the level of ECD teaching competence and/or by providing opportunities for training in support and leadership roles.

### Admission Requirements

**Recognition of Prior Learning (RPL):** The qualification can be achieved as a whole or in part through the recognition of prior learning. Learners who have completed the Certificate at Level 5 should be able to participate in a learning programme(s) that provides the 120 credits not included in the Certificate, i.e. the fundamental learning components and additional electives. The Diploma is also intended to provide direct access to the Degree at Level 6.

### Entry Requirements

In order to achieve the exit outcomes of this qualification, learners need the following knowledge and skills equivalent to NQF Level 4:

- The ability to read, write and use written resource material for learning and teaching in at least two South African languages;
- The ability to understand fundamental mathematical/numeracy concepts; o the
- Applied competence outlined in the core unit standards at Level 4:
- Facilitate Active Learning in ECD Programmes,
- Facilitate Healthy Development in ECD Programmes, and Manage the ECD Learning Programme.


### Tuition Fees

#### Cost and payment plan

- The total cost to obtain the full qualification is R19 600.00 per learner.
- An admin fee of R2000.00 per annum is required at the beginning of each year.
- The total qualification price is R15 600.00 can be paid off over 24 monthly instalments of 650 per month.
- No students will be allowed to participate in final assessments if fees are outstanding.
- Fees do increase should the student exceed the study period.
